- b) The applicant agrees to survey and bar the property line of the portion of the original allowance for road to be used, and agrees to visibly stake the outer limits of the said allowance with 5 cm. x 5 cm. stakes a minimum of one hundred (100) metres or as the Road Superintendent may direct.
- c) The applicant agrees that no work will commence until the Planning Administrator has issued written confirmation that all conditions have been fulfilled.
- d) The applicant agrees to construct an access road to a width of no greater than six (6) metres, and at a distance of no less than three (3) metres from the boundaries of the said allowance, and further agrees that no clearing or cutting will be conducted closer than three (3) metres from the boundaries of the said allowance.
- e) The applicant acknowledges that the access road is not for his or her exclusive use, and agrees that the access road will not be closed off in anyway.
- f) The applicant acknowledges that the municipality will not be responsible for the maintenance of any portion of the original allowance for road.
- g) The applicant acknowledges the municipal recommendation that this location be included on his or her premises liability insurance policy, and proof furnished immediately, in writing, to the Township Office in the amount of \$1,000,000.00.
- h) The applicant agrees to dispose of all slash and other debris within ninety (90) days of cutting.
- i) The applicant agrees to erect in a visible location at the entrance to the roadway, <u>and to maintain,</u> a sign stating "NOT A MAINTAINED TOWNSHIP ROAD".
- j) The applicant agrees to notify the Planning Administrator when construction has been completed in order that the Road Superintendent is directed to conduct a final inspection.
- k) The applicant acknowledges that if the work has not commenced within one (1) year from the date of Council's approving resolution, or is abandoned for a period of more than one (1) year, the approval

shall be considered null and void, and a new application must be filed with the municipality in order to permit work to be recommenced. I) The applicant agrees that all work must be completed within two (2) years from the date of Councils' approving resolution.
