## DEFINITIONS

<b>Non-Resident Rate:</b>	Refers to the applicable purchase rate of cemetery plots by individuals that do not own property or reside full time, in the County of Haliburton, at the time of plot purchase.
<b>Resident Rate:</b>	Refers to the applicable purchase rate of cemetery plots by individuals classified as 'permanent or seasonal resident'; owning property in the County of Haliburton at the time the cemetery plot purchase is made; or an individual who filled one of the previous criteria, but has sold or relocated outside of the County of Haliburton within the previous twenty-four months in order to receive the long term care they require, or at the discretion of the Cemetery Board.
<b>Interment Rights for Full Burial Plot:</b>	<p>Includes rights to inter up to 1 casket + 2 cremations, or 4 cremations plus four (4) cornerstones and installation.</p> <ul style="list-style-type: none"> <li>• **The identity of those to be interred (have interment rights) must be made and declared at the time of all cemetery plot purchases. All changes, revisions and Transfers to Certificate of Interment Rights are subject to a Change/Transfer fee as noted on the Fee Schedule. The greater of 40% and \$250.00 for full burial plot purchases are transferred to a Care &amp; Maintenance Trust fund as per Legislation.</li> </ul>
<b>Interment Rights for Ground Cremation Burial Plots and Niches:</b>	<p>Includes rights to inter up to 2 cremations in one 12" x 12" niche or ground cremation plot.</p> <p>**The identity of those to be interred (have interment rights) must be made and declared at the time of all cemetery plot purchases. All changes, revisions and Transfers to Certificate of Interment Rights are subject to a Change/Transfer fee as noted on the Fee Schedule.</p> <ul style="list-style-type: none"> <li>• For ground cremation burial lots the greater of 40% and \$150.00 for ground cremation plot purchases are transferred to a Care &amp; Maintenance Trust fund as per Legislation.</li> <li>• For Niche burial lots the greater of 15% and \$100.00 for niche plot purchases are transferred to a Care &amp; Maintenance Trust fund as per Legislation.</li> </ul>
