TAKE NOTICE THAT the Committee of Adjustment of the Township of Minden Hills will hold a Public Hearing on:

LOCATION: Municipal Council Chambers
7 Milne Street, Minden, Ontario.

The purpose of the Public Hearing will be to consider a proposed Minor Variance (Application No. PLMV2017002) to the Township of Minden Hills Zoning By-law pursuant to Section 45 of the Planning Act.

Location of the Subject Lands: Part of Lot 10, Concession 12, Geographic Township of Lutterworth; municipally known as 1249 U of T Survey Camp Drive; and located on Gull Lake (see Key Map).

Purpose and Effect of the Application: The applicant wishes to reconstruct the existing boathouse to accommodate a rooftop patio with stairs leading up. In order to permit the development, the applicant seeks relief from the Township's Zoning By-law to permit the increase in height of a non-conforming use (boathouse). The existing height of the boathouse (to midpoint) is 3.1m (10'3"), while the proposed height is 3.8m (12'6") (to top of handrail).

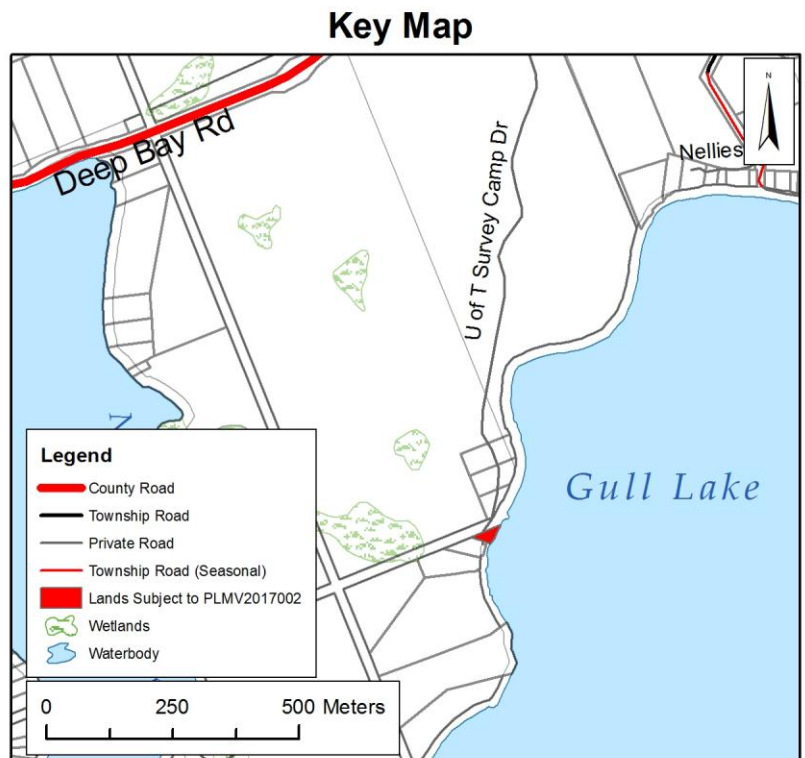

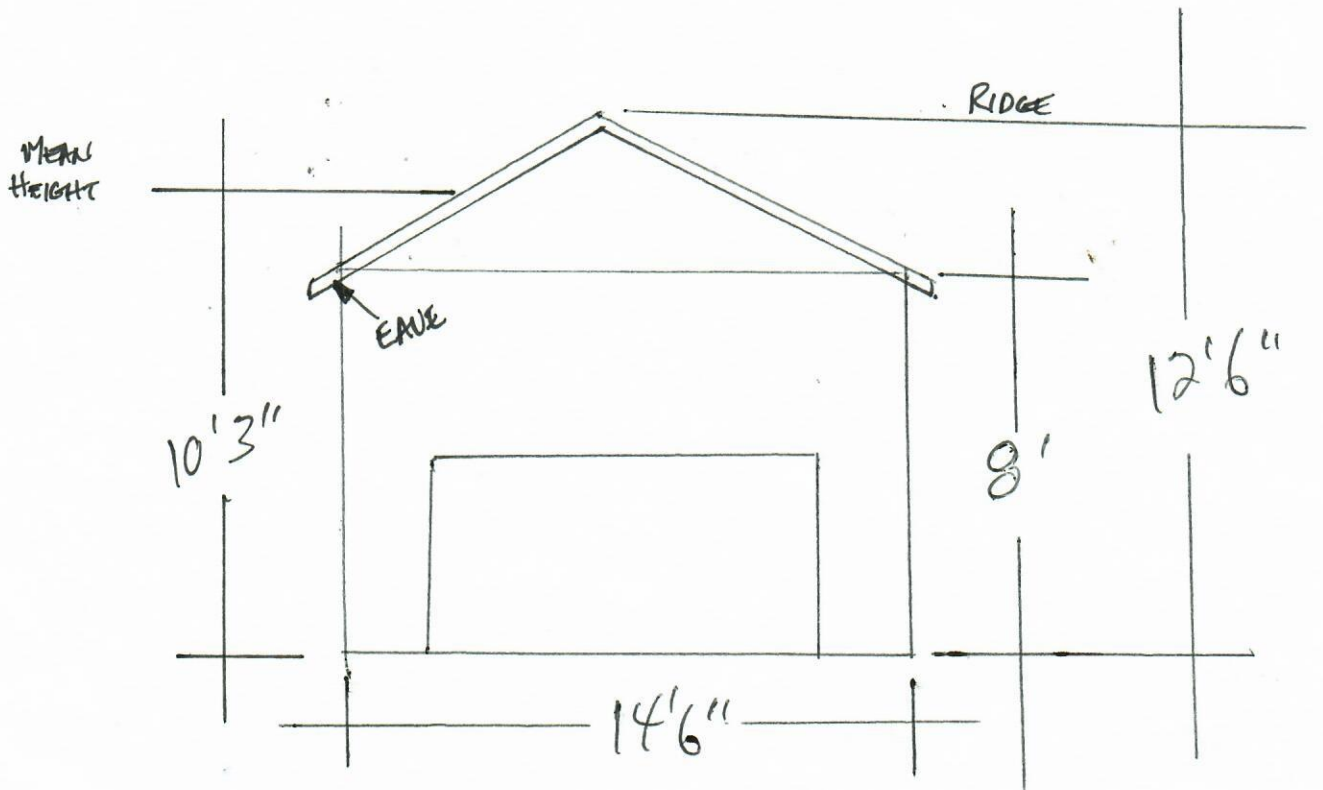
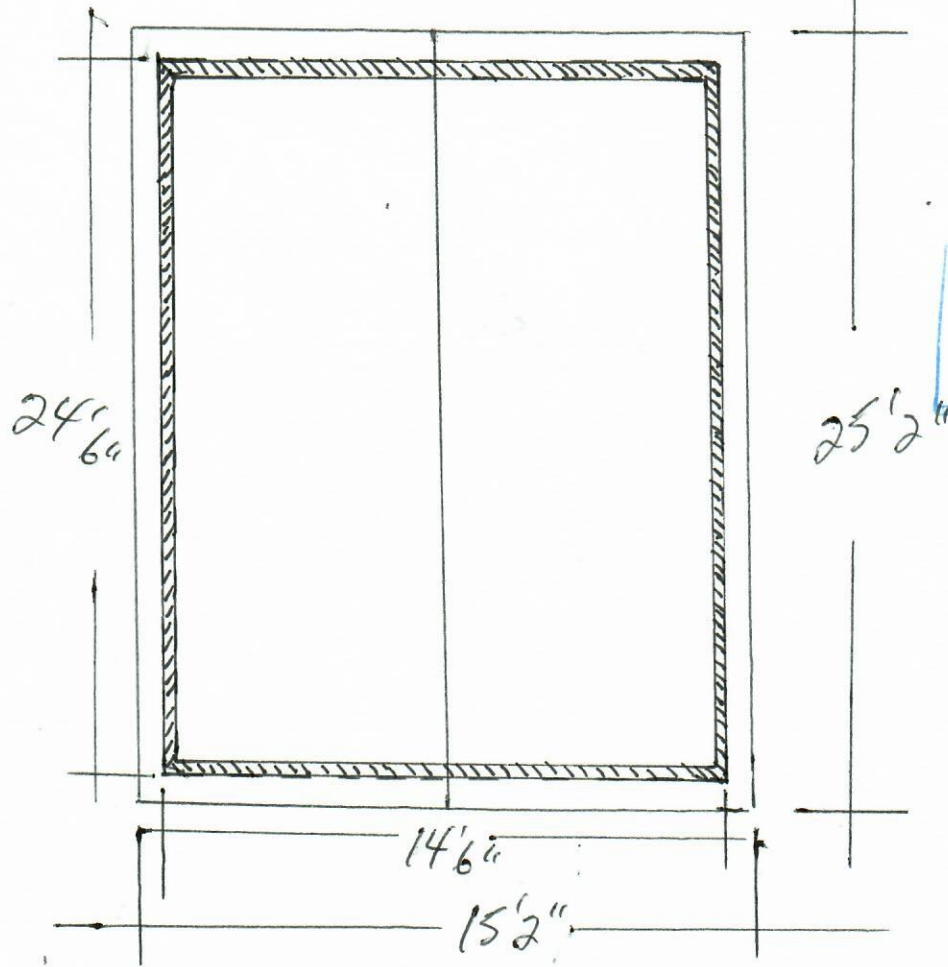
