

## The Opportunity

The Lochlin Community Centre has been a landmark within the communities of Lochlin and Gelert for decades, beginning as a rural school and becoming a central hub for community/neighbourhood gatherings and activities.

During the COVID pandemic the Lochlin Community Centre was closed to the public and remains closed to this day. In its mothballed state, the condition of the building has deteriorated and requires significant investment.

The Township of Minden Hills (Township) is seeking a partner or partners for the redevelopment of the Community Centre and property and is requesting Expressions of Interest (EOI). The redevelopment plan(s) must meet a broad community need and include a community gathering space to serve the neighbouring and broader communities.

The Township Council intends to review proposals and potentially enter into confidential negotiations.

### Background information

The Lochlin Community Centre property is approximately 3.4 acres, located at the corner of Lochlin and Gelert roads (4713 Gelert Road, Lochlin). Currently the property offers, together with the community centre, a playground, horseshoe pits and a baseball diamond.

The frontage along Gelert Road is approximately 806.92 feet. The lands have a westerly depth of 174.47 feet, and easterly depth of approximately 219.45 feet which fronts on Lochlin Road.

There are no known environmental features (e.g. wetlands) on the property. Both roads are publicly owned, year-round maintained by the County of Haliburton (Gelert Road) and the Township (Lochlin Road).

Interested parties will need to also consider continued access for 4683 Gelert Road in their development plans, as the lot is currently accessed through the Lochlin Community Centre property.



## Submission Requirements

## Proposals should outline the following;

- 1. Description of re-development
- 2. Project and Financing Plan
- 3. Reason for submitting the proposal, including fit with the community
- 4. How the proposal meets one or more of the Township's key objectives
- 5. Demonstrated ability to complete the project successfully and in a timely manner

## Proposals must be concise and no more than 5 pages in length

## Selection Process

At this stage, the Township is receiving expressions of interest. All submissions will be reviewed with Council and the Expression of Interest process is confidential.

Short-listed parties may be requested to provide further information and present their proposal to Township staff/Council, within 12 weeks from notice of prequalification.
