**SUBJECT: Water Conditions Update**

**Water Conditions:**

Gull River Watershed

The Gull River Watershed continues to be very vulnerable to the inflow of water. The Gull River has not crested.

Water levels have risen **2 cm** since yesterday and may continue to rise. The Gull River is nearing levels experienced in 2013 and some of the reservoir lakes have exceeded capacity and historic high levels.

It is highly recommended that property owners, especially those who have a historical susceptibility to flooding at these levels continue to make appropriate preparations including sandbagging and self-evacuation for family and pets.

In the event of an emergency and you are unable to evacuate yourself from your residence, call 911. Please indicate that the call is not for a medical emergency but for evacuation from your residence. If you have evacuated, you are encouraged to register at the Red Cross Reception Centre, located at the S.G Nesbitt Community Centre, 55 Parkside Street, Minden.

Burnt River Watershed

The Burnt River has crested and has begun to rapidly recede. Extreme caution is still encouraged. The public and residents are to avoid areas with fast flowing and high water levels.

All Property owners are being asked to monitor their situation, as each will vary based on some, or all of the following factors: distance from watershed(s), distance from an unaffected accessible road, height of land, property saturation levels, the availability, number, size and type of sump pump, etc.

**General:**

**For public safety reasons it is critical that no one other than TSW officials are to perform log adjustments to local dams. This could result in serious implications to the management of the flow of water and balancing of the watershed levels.**

Owners of waterfront properties are asked to secure any loose items such as outdoor furniture, boats, docks, etc.

For information regarding **Available Services** please refer to Media Releases provided on the Township website. This releases will be updated as information changes or becomes available.

Residents are asked to share this information with their neighbours and other individuals who may not have access to the Township's website.

Many of the local ditches are holding water, and residents are reminded to stay clear of these areas.

### **Road and Bridge Closures:**

For current and comprehensive list of road and bridge closures, please refer to Media Release #17-39.

The Minden Riverwalk, Loggers Pedestrian Bridge, Boardwalk and Rotary Park are **CLOSED**.

Signs and Barricades have been posted at roads closed due to flooding.

**DO NOT** drive on these roads unless signage indicates “open to local traffic only”. Roadways under water may create unstable and dangerous conditions.

**DO NOT** remove barricades and signage.

A reminder that private roads are not being monitored by the Township and those residents needing to access these roads should do so with caution.

### **Downtown Area Closures:**

For the following reasons, the road closures provided below will be in effect:

- Public Safety
- Protection of Municipal Infrastructure
- Access for Emergency Services to the downtown area

#### **Please obey and DO NOT REMOVE barricades and signs**

- The **Bobcaygeon Road “Sunnybrook” Main Street Bridge** is **CLOSED** to vehicular traffic and all pedestrian use, until further notice.
- **At 6:00 pm, Thursday, May 11, 2017, until further notice**, the following roads will be **CLOSED** to vehicular traffic and non-essential pedestrian use.
  - **Bobcaygeon Road** at the intersection of Newcastle Street
  - **Milne Street** at the intersections of Water Street and Newcastle Street

**Bobcaygeon Road** and **Newcastle Street** at Highway 35, will remain open at this time.

**Booth Street** connecting to Prince Street remains closed.


**Map:**

Access to the Minden hospital is as follows, **please refer to the detour signs:**

- Hwy 35 to Deep Bay Road (19 km distance in total)
- Hwy 35 to Scotchline Road, left onto Bobcaygeon Road and right onto Deep Bay Road (5.5 km distance in total)

**Sandbags:**

Sand and sandbags continue to be available at the following locations:

- S.G. Nesbitt Community Centre, located at 55 Parkside Street, Minden.
- Roads Department Yard #3, located at 4564 County Road 121 (Kinmount location), in the Sand Dome to the left of the entrance.

- Furnace Falls Park entrance, located on County Road 503.
- Lady Fatima Catholic Church, 7 Bobcaygeon Road (off of Hwy 35 at the intersection of Bobcaygeon Road and IGA Road)

This resource is primarily self-serve, please remember a shovel. Residents are encouraged to think of their neighbours - don't forget about those around you that may have difficulty with this task.

**Limited quantities of prepared sandbags will be available at the S.G. Nesbitt Community.** We kindly ask that you consider others and their ability to prepare their own sandbags when accessing this service.

### **Suggestions to Assist you During a Flood Warning:**

- Be Prepared - Build an Emergency Survival Kit that allows you to be self-sufficient for at least 72 Hours.
- Keep Emergency Contacts Near Your Phone
- Check Your Sump Pumps - Ensure the sump pit is clear of debris and that all electrical connections are plugged in correctly and circuit breakers are operational. Check your maintenance manual for instructions on how to check the float, test the check valve and clean the impeller.
- Hydro – If you are concerned about water in or around your residence, or other buildings, call the Hydro Call Centre at 1-888-664-9376. Disconnected services may impact water removal equipment (i.e. sump pumps); therefore, it may also be necessary to contact your insurance company.
- Remember to keep all items up and off the floor where potential flooding could occur.

- Select other categories if interested in receiving notifications.
- Select save.
