# Canadian Red Cross Financial Assistance

Red Cross is offering financial assistance for those who have been <u>affected by the flood</u>. To receive direct financial assistance, you <u>must register</u> with Red Cross. Registration can be done by one of the following:

- Telephone 1-800-863-6582.

All eligible households will receive \$600 in direct financial assistance through an electronic bank transfer. Damage must be to principle residence.

# **Direct Financial Assistance**



The person representing your household must register.

<u>IMPORTANT</u> – if you have already registered with Red Cross here in Minden, you will need to **re-register** through this program by one of the methods listed above. Please be patient when calling due to anticipated high volumes of callers.

The public is also advised that Red Cross **will not** be calling individuals asking for banking or other personal information. If you receive these types of calls, do not provide any information. If you receive a suspected fraudulent call, please report to the Minden OPP at 1-888-310-1122.

Individuals, businesses and organizations who have been affected by the flood are strongly encouraged to register at the Red Cross Reception Centre.

The Red Cross Reception Centre daily hours of operation have changed to:

10:00am to 7:00 pm - S.G. Nesbitt Arena & Community Centre, 55 Parkside Street

This will assist the Township in determining the immediate needs of those affected by the flooding, and will also assist in the recovery efforts.

#### **Clean-Up Kits**

Clean-Up Kits are available at the Red Cross Reception Centre located at the S.G. Nesbitt Arena & Community Centre, 55 Parkside Street, daily from 10:00 am to 7:00 pm., until further notice.

#### Disposal of Flood Related Waste/Items/Debris

The Township will begin curbside collection of **household waste only** for the **following flood affected streets** and roads:

- Anson Street
- McKnight Street
- Orde Street
- Invergordon Street
- Water Street

- Prince Street
- For other areas, residents are to call to the Township office at 705-286-1260.

Collection will continue on the following dates, at 8:00 am:

- Tuesday, May 23, 2017 (if required)
- Friday, May 26, 2017 (if required)

Individuals, businesses and organizations, who have been affected by flood damage, may also dispose of this waste directly at any of the Township Landfills - according to current landfill hours of operation and according to what is currently being accepted at each of these sites.

There is no fee for flood related waste material, however you will be asked to complete a brief form, so that the Township can track the amount of material received. Forms are available at the Township Administration office, located at 7 Milne Street (accessible from St. Germain Street), the Red Cross Reception Centre, and Scotchline Landfill and transfer stations.

#### **Donations**

Individuals, businesses and organizations interested in financial or material donations such as non-perishable food, clothing, toiletries, bedding etc. are encouraged to seek out a local community organization of their choice (churches, service clubs etc.), and the Minden Food Bank.

The <u>Canadian Red Cross</u> accepts financial donations only and can be made online or by telephone.

Please be advised that the Minden Food Bank does not require donations of bedding and toiletries at this time.

The Foodbank however is in need of fresh and frozen vegetable donations, and assistance in providing meals, including preparation, serving and clean up. Please call 705-286-6838.

Please continue to check future media releases or contact the Minden Food Bank for up-to-date information regarding this, and other needed items.

The Township would like to thank everyone for their donations and offers of assistance to the Township and other non-profit groups and organizations.

#### **Door to Door Visits**

The Red Cross, Health Unit and Fire Department will be continuing their door to door visits to conduct a basic needs assessment of those residents affected by the flood and to provide information on recovery and clean up. Please refer to Media Release #17-64 for more information.

#### **Emergency Operations Centre (EOC)**

The EOC continues to operate in accordance with the Township's Emergency plan and Procedures. The control group is working with various government agencies, including Trent Severn Waterway and the Ministry of Natural Resources & Forestry to communicate all information by means of media broadcasting and media releases to radio stations, local newspapers and our website.

# **Health Unit**

Please visit the Health Unit website for information regarding potentially spoiled food, wells, malfunctioning septic systems and boiled water advisory, etc.

Residents with <u>private wells</u> are reminded to contact the **Health Unit** regarding the safe use and consumption of well water, in the event that the well may be affected by ground water. Information regarding water testing bottles and drop-off locations can also be obtained from the Health Unit at 1-866-888-4577.

- Minden Hills Public Library, 174 Bobcaygeon Road. Tuesdays and Wednesday's between 10:00 am and 8:00 pm.
- HKPR Health Unit Haliburton office, 191 Highland Street, Haliburton. Monday to Friday, 8:30 am to 4:30 pm, daily.

# **Sandbags**

The Township will begin collecting sandbags on **Wednesday May 24**<sup>th</sup>. Please note that it is <u>Curbside pickup only</u>.

Residents and businesses wishing to repurpose the sand contained in sandbags, for landscaping, gardens etc., may do so. Please be advised that sandbags may contain a sand and salt mixture.

Sandbags can also be taken to the Scotchline Landfill only, at no cost.

- Select "Newsroom" to receive all other non-emergency posts, including water levels and road closures notifications.
- Select other categories if interested in receiving notifications.
- Select save.
