### Terms

**Applicable laws.** The Applicant agrees that they have read and understood, and that they will comply with, all applicable Federal, Provincial and Municipal laws, orders, standards, policies and guidelines.

**Turn-On/Shut-Off of Service.** Only the Township of Minden Hills may shut-off or turn-on the service to the property. The Applicant shall pay all costs incurred by the Township of Minden Hills to shut-off and/or turn-on the service to the property within 30 days of demand of same. Such costs shall include, but are not limited to, the costs of labour, materials, equipment, overhead and administration.

**Indoor Plumbing Fixtures.** The Applicant agrees that while the service to the premises is shut-off it is the Applicant's responsibility to ensure that all indoor plumbing fixtures and/or valves are in the "off" position and to take all necessary measures to protect any plumbing items which service the premises (e.g. hot water tank). The applicant accepts the responsibility of the safe keeping of the water meter.

**Indemnity and Release.** The Applicant hereby releases and will indemnify and save harmless the Township of Minden Hills and all of its Employees, Agents, Officers, Elected Officials and Directors from and against all claims, demands, causes of action, suits, losses, damages and costs (including all actual legal and consultant costs), liabilities, expenses and

judgments which the Township of Minden Hills incurs, suffers or is put to, arising out of or in any way related to the following:

- (a) Applicant's breach of the terms and conditions of this permit, including for certainty, anything required to be done or maintained by the Applicant hereunder or anything not done or maintained by the Applicant as required hereunder, and
- (b) a negligent act or omission or willful misconduct by the Applicant or any Employee, Agent or Contractor of the Applicant, unless such claims, demands, causes of action, suits, losses, damages and costs, liabilities, expenses and judgments arise directly or indirectly from the Township of Minden Hill's negligence. This term will survive the rescission, voiding or expiry of this permit
